# **INTERESTS**

## **Guidance Note for Members**

### **Completing the Register**

Under the Local Government Act 2000, the Clerk & RFO is required to establish and maintain a Register of Members' Interests.

Paragraph 3 of the Code of Conduct for members of local authorities in Wales adopted by Solva Community Council on 4<sup>th</sup> October 2017, requires Members and co-opted Members of Solva Community Council to register in the Register of Members' Interests any interests which fall within a category mentioned in paragraph 3.8 of the Code of Conduct, by providing written notification to the Clerk & RFO.

Each Member has been given an individual Register like this one to complete and return. The Clerk & RFO keeps these together to form the statutory Register of Members' Interests. Each Register can be updated as necessary and will be reviewed by each member every 6 months.

The categories of interests mentioned in paragraph 3.8 of the Code are set out on pages 52 & 53. Members are required to register any interests which fall within these categories by inserting details in the space provided. **Members who have no such interests should write 'none' in the space provided.**

This Register must be completed and returned to the Clerk & RFO within 28 days of your election or appointment to office.

### **Notifying the Clerk & RFO of any changes**

You must, within 28 days of becoming aware of any new personal interest or a change to any personal interest which has already been registered, register that new personal interest, or change by providing written notification to the Clerk & RFO.

### **Notifying the Clerk & RFO of any interests disclosed during meetings**

When you disclose an interest orally at a meeting of SCC, you must ensure the details are reported in the Minutes of the meeting.

3. **CONTRACTS WITH SOLVA COMMUNITY COUNCIL** [Paragraph 3.8 of the Code of Conduct] **If none, write NONE.**

You must describe all contracts for goods, services or works, of which you are aware and that are not fully discharged, made between Solva Community Council and yourself, a firm of which you are a partner, a company of which you are a remunerated director, or a corporate body in which you have a beneficial interest (that is, in which you have some interest for your own benefit). **If none, write NONE.**

4. **LAND IN THE WARD OF SOLVA COMMUNITY COUNCIL** [Paragraph 3.8 of the Code of Conduct] **If none, write NONE.**
